TYPE I BARRICADES & 18" TRAFFIC CONES

The Board of Eaton County Road Commissioners has advertised for bids to be received at 1112 Reynolds Road, Charlotte, Michigan 48813, until 6:45 p.m., Tuesday April 28, 2015, for furnishing and delivering TYPE I BARRICADES and 18" TRAFFIC CONES in accordance with the following specifications.

Bid prices shall include the cost of delivery to 1112 Reynolds Road, Charlotte, Michigan and shall remain firm until April 1, 2016.

All barricades shall conform to the requirements of the current Michigan Manual of Uniform Traffic Control Devices.

TYPE I BARRICADE

Minimum height 36" top of board to roadway when in the open position and minimum width to be 24".

Use exterior plywood, minimum 5 ply 1/2" x 8" with reflective sheeting (Engineering Grade II) orange and white. Frame work to be 1/8" x 1-1/4" right angle steel minimum. Painted with white industrial enamel.

Hinge bolts to be minimum 1/2". Diameter for alternate mounting of a warning light support, plywood minimum 1/2" x 8" exterior plywood painted (white).

All portions of barricade, including metal legs not covered by reflective sheeting to be painted with white industrial enamel.

The top board on one side shall have reflective sheeting starting from the top right sloping downward to the left. On the reverse side the top board with reflective sheeting shall start at the top left sloping downward to the right.

18" ORANGE TRAFFIC CONES
