The Board of Eaton County Road Commissioners has advertised for bids to be received at 1112 Reynolds Road, Charlotte, Michigan 48813, until 9:00 a.m. Tuesday, April 11, 2017, for LAWN CARE SERVICE in accordance with the following specifications.

Bid prices shall include the cost for lawn care service at three locations indicated on the bid blank and shall remain firm until March 31, 2018. This contract may be extended for one year by the mutual agreement of both parties. Requests for extension must be made in writing to the Superintendent by February 15, 2018.

SPECIFICATIONS

WEATHER CONSIDERATIONS

It is mutually understood that all of the services provided herein are weather driven and the dates included in these specifications are provided as general guidelines for the successful bidder.

DAMAGES

The successful bidder shall be responsible for any damage to buildings, vehicles, windows or any other asset occurring while performing lawn care duties.

LOCATIONS

MOWING

The successful bidder shall mow and trim around buildings, shrubs, trees, and flowers, side walks shall be clean of grass clippings. Mowing services are on a weekly basis or as needed upon approval of the Eaton County Road Commission Equipment Supervisor. Mowing shall begin approximately April 15, 2017.

ADDITIONAL WORK

Any additional work shall be described and a price agreed upon between the successful bidder and the Eaton County Road Commission Equipment Supervisor before said work is performed.
